Dear BRADLEY S STOKER,

We are pleased to inform you that your COMMERCIAL pesticide applicator license has been reissued and is enclosed. Your license is effective as of August 17, 2018 and will expire at midnight on August 31, 2019. Please review the information printed above and on your license carefully. You are required to notify the Texas Department of Agriculture within 30 days of any change in the information you provided in the application or renewal of this license.

A client number has been printed on your certificate. This number will be used to provide you with more efficient service by acting as a cross-reference to all TDA licenses you may obtain, as well as any other contacts you may have with TDA. By referencing your client number, both you (through Internet access) and authorized TDA personnel will be able to review and process most or all of your licensing, license renewal and contact information from a single access point.

A COMMERCIAL applicator license authorizes you to purchase and apply, or supervise purchases and applications of restricted-use and state-limited-use pesticides or regulated herbicides to the land of another person for hire or compensation. You may only make such applications in circumstances covered by the use categories for which you are certified. These categories appear as endorsements on your license.

To renew this license, you will need to obtain five continuing education units (CEUs), prior to renewal of the license. The required five CEUs must include a minimum of one hour each from two of the following continuing education categories: integrated pest management, laws and regulations, or drift minimization. Additional requirements pertaining to CEUs and a list of approved courses can be obtained from TDA's web site or by contacting TDA's Pesticide Certification and Compliance program at our Austin headquarters at (800) TELL TDA (800-835-5832).

For commercial and noncommercial applicators certified in the AERIAL application category, three of the required five CEUs must be associated with aerial application operations to include one CEU each in: laws and regulations; drift minimization; and pesticide safety addressing "human factors".

PLEASE NOTE: TDA will randomly audit a number of applicators to check for compliance with CEU requirements. If you are selected for audit, you will receive a letter asking you to send TDA a copy of each certificate of completion you received during the relevant time period. You may also be asked to provide access to or copies of CEU documentation during routine or complaint-related inspections.

Applicators are required to keep certificates of completion for 12 months following renewal of a license. 4 TAC§7.24(s)

Regulations and statutory provisions governing pesticide applicator licensees and their use of pesticides may be found in Chapter 7, Title 4, of the Texas Administrative Code and Chapter 76 of the Texas Agriculture Code, respectively. TDA's web site provides convenient links to these laws. Failure to comply with these laws, including misuse of any pesticide, may result in revocation, suspension, modification, or probation of your license and/or assessment of monetary administrative penalties.
